Vice Mayor Wiggins made a motion to approve the agenda. Alderman Hummel seconded the motion. All were in favor, none opposed.

5. Reading and Correction/Approval of Minutes of Regular Board

December 14, 2023 – Regular Board Meeting Minutes

Alderman Cates made a motion to approve the December 14, 2023 Regular Meeting Minutes. Vice Mayor Wiggins seconded the motion. All in favor, none opposed. The motion passed.

6. Resolution 24-09 Official Censoring of Board Member

Vice Mayor Wiggins made a motion to approve Resolution 24-09. Alderman Cates seconded the motion. Three (3) in favor, one (1) abstained. Roll-call results: Alderman Cates, Hummel and Wiggins voted in favor with Alderman Sutton abstaining. Resolution 24-09 passed.

8. Communications from the Mayor

Mayor Brown thanked Public Works, Water, Police and Fire for a job well done, especially with the extreme weather conditions of the past week. The mayor stated several citizens had contacted him, expressing their thanks.

9. Communication from the Aldermen

Vice Mayor Wiggins wished everyone a happy new year.

Aldermen Cates inquired of gift-giving ("Code of Ethics") as it relates to Board Members. Attorney Minor referenced Ordinance 1-103 governed by Roberts' Rules of Order, but stated there was no Code of Conduct in place. Alderman Sutton asked was that the case for both Officials and employees, which, Attorney Minor stated the employees are to follow the "Employee Handbook." It was the consensus of the Board to have Attorney draft a "Code of Ethics" and present it at the meeting. Vice Mayor Wiggins offered a copy of the Fayette County Commissioners ethics code as a guideline.

Alderman Hummel recognized both Director Armstrong and Director Coker for giving the tour of the Water and Wastewater Plants to a couple of Girl Scouts (Troope #13108) who were earning their last badge (related to water) before going away to college.

Alderman Sutton thanked the Water Department and Blake for their efforts in keeping the towns water safe. He also encouraged citizens, as well as board members, to contact their legislators regarding the placement of flock cameras throughout our town. Mayor Brown stated, Home-Owners Associations have the right to request the cameras from local authorities. He said he plans to make a recommendation to his HOA in making that request.

10. Department Head Reports

Finance Director Hodges notified the board the FY2023 Audit is complete, and the auditors are scheduled to make the audit presentation at the February workshop. She recognized Stacey Grooms and Natasha Edmonds in getting over 3,000 property tax checks entered.

Vice Mayor Wiggins inquired of the fluctuation of the sales taxes reported on the December 2023 Recap. Laura stated she would research the information further, reporting back to the board.

11. Town Manager Report

Mr. Ellis expressed his thanks to all employees of the Town of Oakland for all they do.

Referring to documentation provided to each board member, "Debt Obligation Report" (\$7M dollar), Town Manager Ellis explained the process of presenting this to the board in a public meeting as required by the TN Comptroller. No action was necessary.
